Directions

Orchards and Vineyards

Spray 1/2-2 lbs. FP-LL15 Fish Hydrolysate mixed in 100 gallons of water per acre. Begin 4-6 spray sequence at pink-bud or half leaf emergence and repeat at 7 to 10 day intervals. May be tank mixed with most orchard and vineyard spray materials.

Row Crops

Spray 1/2-1 lbs Kappa Sap mixed in 100 gallons of water per acre on emerging new growth and at other plant growth stages when an immediate nutritional boost may be beneficial to growth, production and quality.

Ground Application

Pre Plant: Utilize between 10 and 150 pounds dependant on soil needs and structure. In heavily depleted soil settings higher applications rates will benefit the rebuilding process that must take place. Add to compost or pellets to aide in distribution during application.
